In accordance with 15A NCAC 11 .1418(h), (k), Records: Reports and Operating Requirements for tanning facilities, all operators of tanning equipment must have successfully completed a formal training course. The training course must have been approved by the agency. All operators must be 18 years of age or older to operate tanning equipment.
